- Thought leadership
- Contribution to LP programs that protect restaurants, customers and employees
- Development and implementation of innovative strategies or programs to address restaurant security challenges
- Key metrics and benefits achieved
- Representing the standards and procedures of RLPSA and the restaurant security industry

**Guidelines for Nominators**: Only current foodservice or service provider employees qualify for nomination. We suggest third-party nominators notify the nominee before submitting a nomination. Individuals are welcome to nominate themselves.
